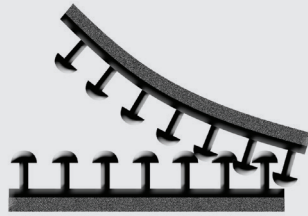

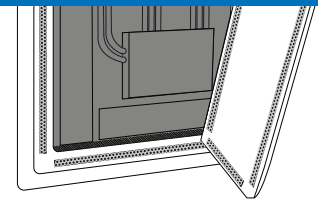

- Suited for indoor and outdoor use



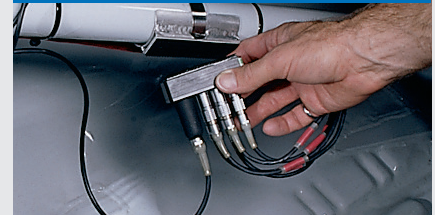
Access panel attachment on machinery, such as CNC machines, injection molding equipment, appliances and more.
